Crime Stoppers of Pike County awards a one-time, non-renewable \$1,000 scholarship to assist a high school graduate who intends to pursue a career in Law Enforcement and/or Criminal Justice.

The Scholarship is made possible by donations of local citizens and businesses. To be eligible, the applicant must be a graduate of a Pike County, Illinois high school and be a permanent resident of the county at time of graduation, and have declared an interest in a career in Law Enforcement and/or Criminal Justice. The scholarship is granted for the purpose of assisting this student with the costs of tuition, books, fees, and approved housing.

Application forms are available from Crime Stoppers or through high school guidance counselors. Completed applications must be returned to Crime Stoppers no later than **April 1**. Applications will be reviewed by a committee of non-partisan citizens who will review, evaluate, and select the winner(s). The name(s) of those selected will be announced by June 1.

The total award will be divided as follows: after proof of completion of the first semester grading period of the college or university the student is attending, \$500 will be paid directly to the student if their grade point average (GPA) is 3.0 (B average) or higher.

It is the student's responsibility to send grades to Crime Stoppers as soon as possible after completion of the semester. Funds cannot be used for summer courses and must be used during one school year.

To receive the remaining \$500 of the award, the student must send grades of the second semester to Crime Stoppers showing a GPA of 3.0 or higher. The second payment will be paid directly to the student upon proof of completion and GPA requirement met.

There shall be no restriction on any applicant by reason of race, age, creed, color, sex, or national origin. The only limitations are the following:

- Applicant must have been a permanent resident of Pike County, Illinois for at least 1 year and a graduate of a Pike County high school
- Student must be enrolled as a full-time student with at least 12 hours per semester and maintain a 3.0 GPA
- Scholarship must be used at an accredited institution of higher learning and part of the curriculum for a degree in Law Enforcement and/or Criminal Justice
